CPAA has made part of its mission, to interact with post-secondary planning students. We have interacted with the University of Calgary (U of C) for years, since they were the only location with a planning program. In 2010 we expanded our initiative to include the University of Alberta (U of A). You will have noted we had several student volunteers at the 2010 conference from both U of A and U of C. In 2011 we will expand our inclusion to the University of Lethbridge (U of L), when the Board meets with students from a variety of programs who offer planning courses. Look for students participating at the 2011 conference from all three institutions.

CPAA includes two student positions on our Board of Directors, and each Director mentors a student at the annual CPAA conference for their learning experiences. This is an opportunity for everyone to introduce themselves to future planning practitioners in our province, and CPAA provides price breaks to student conference costs.

It is all of us working together that makes the students cognizant of the community planning needs in Alberta. Thank you for working with us in this important piece of our future.

CPAA WORKING TO IMPROVE ALBERTA'S PLANNING EDUCATION Don Schultz

To raise awareness of Alberta's planning education crisis and to find solutions that will lead to the re-establishment of an accredited planning program in Alberta, the CPAA Board of Directors has engaged in a program of advocacy with organizations such as the Alberta Professional Planners Institute (APPI, formerly AACIP), the Alberta Association of Municipal Districts & Counties (AAMD&C), the Alberta Association of Urban Municipalities (AUMA), Alberta Municipal Affairs, and Alberta Advanced Education & Technology. As a result of this advocacy, CPAA, APPI, AAMD&C, and AUMA have all adopted resolutions and policies calling upon the Government of Alberta to provide stronger support for planning education.

In September 2009, the CPAA Board of Directors approved a motion "that CPAA make connections and cooperate with other like organizations concerned about planning education in the province to increase planning education funding." In April 2010, APPI Council adopted a specific policy on advocacy for planning education "that the role of APPI in advocating for re-establishment of a fully accredited university planning program in Alberta includes:

- general advocacy in concert with other organizations for political and financial support at the Provincial level to establish an accredited university planning program in Alberta, and
- specific advocacy on behalf of particular institutions, provided that those institutions have demonstrated that they can satisfy national CIP accreditation requirements."

In March 2010, AAMD&C adopted a resolution that "encourages the Government of Alberta to:

- 1. Assist one or more universities in Alberta in creating and operating an accredited planning program; and further,
- 2. Allocate funding to implement and operate an accredited planning program at one or more universities in Alberta."

Most recently, in November 2010, AUMA adopted a resolution to "strongly encourage the Government of Alberta to work with academic institutions in Alberta to establish an accredited professional planning program in at least one Alberta University by September 2011."

In addition to promoting all of these polices and resolutions, the CPAA Board of Directors has been facilitating dialogue amongst our partner organizations and the Government of Alberta. Members of AAMD&C have met with senior administration at Alberta Advanced Education & Technology to advocate for stronger planning education, while AUMA has exchanged correspondence with Alberta Advanced Education & Technology Minister Doug Horner addressing the need for a revitalized planning education in this province.

CPAA has been working closely with APPI to coordinate advocacy in this endeavour. In September 2010, CPAA and APPI met with both Alberta Advanced Education & Technology Minister Doug Horner and Alberta Municipal Affairs Minister Hector Goudreau to discuss potential solutions to this problem and to explore ways in which CPAA and APPI could assist the Government in supporting stronger planning education in Alberta.

It is clear from the September 2010 meeting that both Ministers Goudreau and Horner recognize the need for better planning education and support our efforts to find solutions. More than acknowledging this need, these two Ministers agree that the need is urgent and that action must be taken immediately so that new professional planners who are educated in Alberta will be able to start serving our communities as soon as possible. This common acknowledgment of Alberta's planning education crisis has established a strong spirit of cooperation among those Ministries, CPAA, APPI, AAMD&C, and AUMA.

Following the September 2010 meeting with Ministers Goudreau and Horner, a delegation of representatives from CPAA and APPI met in November 2010 with senior administration at Alberta Advanced Education & Technology to map out a plan of action for re-establishing university planning education programs in Alberta. Key to this initiative will be coordination with an organization under the purview of Alberta Advanced Education & Technology, known as the Campus Alberta Quality Council. Another outcome from that November 2010 meeting will be outreach to other champions of higher education to spearhead our multi-pronged advocacy. The CPAA Board of Directors will continue to work with our partner organizations over the winter of 2010-2011 to develop a coordinated approach to the delivery of planning education that will draw upon the resources of multiple institutions of higher learning across the province.

This multi-institutional approach to providing planning education recognizes a new environment that is emerging around the world, which is requiring that governments, universities, professional societies, and community organizations find new ways to educate, train, and develop professionals. CPAA looks forward to continuing this collaboration with the Government of Alberta and our partner organizations. We will keep our members and other readers of the Alberta Planning Exchange informed as we work toward our common goal of re-establishing an accredited system of planning education in Alberta.
